May kindly see the property statement received online from Sri Pankaj Srivastava, Addl. District & Sessions Judge, Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.27,03,563/- and total deductions/savings/investment against NPS, GIS, RD, Insurances/Policies, Sukanya Samridhhi Yojna Account, Car Loan repayments including down payment and Income Tax is Rs.13,97,536/- and the balance of his savings bank account(s) is also increased by Rs.1,37,693/- in this financial year from previous year's balance, total of which is Rs.15,35,229/-. Thus, a sum of Rs.11,68,334/- was therefore available with him to meet out the household expenditure of his family consisting of four member for the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial Service, online against Case Id : P00005462023 and the same has been seen by Hon'ble Mr. Justice Rahul Chaturvedi, the then Administrative Judge, Gorakhpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 06.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Pankaj Srivastava, Addl. District & Sessions Judge, Gorakhpur, be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
