May kindly see the property statements online received from Sri Avinash Kumar Singh, Additional District & Sessions Judge, Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total Gross income is Rs.29,65,338/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF a/cs, Insurance policies, NPS, PLI, FGLIC and the balance of his savings bank account(s) is enhanced for Rs.4,77,026/- this financial year from previous year's balance, total of which is Rs.15,43,413/-. Thus, a sum of Rs.14,21,925/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife earns Rs.2,40,000/- per annum from House rent.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2016-17 which had already been seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Moradabad, placed in the mIs. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March, 2020. He has submitted movable and immovable property statements for the financial years 2017-18 & 2018-19 firstly vide online dated 20.11.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "his unconditional apologies for not sending his property statement for the year 2017-2019 due to heavy rush of work", mentioned in remark column of movable property proforma.

May, therefore, if approved, property statements for the financial year 2017-18 & 2018-19 of Sri Avinash Kumar Singh, Additional District & Sessions Judge, Jhansi be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Jhansi Judgeship for Her Lordship's kind perusal and orders?
