May kindly see the property statement online received from Sri Mahendra Kumar Singh, Chief Judicial Magistrate, Sant Kabir Nagar at Khalilabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross income from salary is Rs. 28,19,611/- and total deductions/savings/ investment against CPF, GIS, PPF, Income Tax, Insurances , SIP and the balance of his savings bank account(s) is also enhanced by Rs.2,97,826/- in this financial year from previous year's balance, total of which is Rs.16,87,312/-. Thus, a sum of Rs.11,32,299/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the both of the financial year.

It is pertinent mention here that officer wife (Teacher) having annual income Rs.5,60,528/- & Rs.6,38,767/- respectively for the financial year 2017-18 & 2018-19.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2015-17 (2015-16 & 2016-17) offline and same has been processed before Hon'ble Mr. Justice Om Prakash Tripathi, Administrative Judge, Sant Kabir Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 19.11.2021. As such, there is delay in submitting the same. In this regard, officer stated that the undersigned is extremely sorry for the incessant delay in submission of property statement due to health reason of his parents, who are in their old age and further assures to be careful and punctual in future...
