May kindly see the online reply received from Sri Asif Iqbal Rizvi, Additional District & Sessions Judge, Saharanpur, in compliance of order of Hon'ble Mr. Justice Rajiv Gupta, the then Administrative Judge, Saharanpur in the matter of property statement, communicated to the officer.

In this connection, it is submitted that earlier the officer had submitted his movable & immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) which were put up before Hon'ble Administrative Judge, Saharanpur through detailed online office note on which His Lordship has been pleased to pass the following online order:

"The officer be asked to submit explanation within fortnight regarding delayed submission of property statement."

The order of the Court had been communicated to the officer concerned.

The officer concerned has replied that "he is submitting his explanation through the letter attached herewith along with enclosure mentioned therein in the form of attachments in compliance of order passed by Hon'ble Court. He, therefore request that kindly place it before Hon'ble Court for its kind perusal and acceptance of his explanation and stated (in his verbatim) in attachments that *I had sent my property statement of year 2016 to 2018 on 30-3-2019 through District Judge, Shahjahanpur. That statement had been sent offline. Thereafter, I submitted my next due property statement for year 2018 to 2020 in December 2020 on e-services portal vide Case Id:P000099462020 Old Case Id:1834. Probably, on that statement an objection was raised by Admin 4 section, whereby I was directed to submit property statement of year 2017 to 2019 on e-services portal. Hence, probably in compliance of that objection, I submitted the said property statement of year 2017 to 2019 on e-services portal in year 2021 vide Case Id:P00010922021 Old Case Id:3187. Now that objection is not viewable from my e-services portal, rendering me incapable to mention the reference with exactitude. Hence, probably in that way my statement got delayed. In future I will try my best to submit my property statement with in time. I, therefore request your goodself that kindly place my submission regarding delayed submission of property statement of year 2017 to 2018 before Hon'ble Court for kind perusal. I shall be obliged for this kind favour."*

Here, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2017-19 (2017-18 & 2018-19), Gross income from salary is Rs.29,79,242/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Insurances, Repayment of loan and the balance of his savings bank account(s) is also enhanced by Rs.2,48,772/- in this financial year from previous year's balance, total of which is Rs.12,44,354/-. Thus, a sum of Rs.17,34,888/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

It is pertinent to mention here that his wife is Judicial Officer having annual income of Rs.12,90,487/- and Rs.20,69,465/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-17, which has been seen by Hon'ble Mr. Justice Piyush Agrawal, the then Administrative Judge, Mau placed in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-18 firstly vide offline letter dated 30.03.2019 and 2017-19 firstly vide online dated 22.11.2021. As such, there is delay in submitting the property statement from the part of the officer for which officer has given the reason of delay (mentioned in his reply/ attachment dated 06.04.2023), in compliance of aforesaid Hon'ble Court's order.

May, therefore, if approved, property statement of the financial years 2017-19 (2017-18 & 2018-19) alongwith reply of Hon'ble Court's Order as desired by the Court in the matter, furnished by Sri Asif Iqbal Rizvi, Additional District & Sessions Judge, Saharanpur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders?
