May kindly see the property statement online received from Sri Mahendra Kumar Singh, Chief Judicial Magistrate, Sant Kabir Nagar at Khalilabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs. 31,31,475/- and total deductions/savings/ investment against CPF, GIS, PPF, Income Tax, Insurances , SIP and the balance of his savings bank account(s) is also enhanced by Rs.49,774/- in this financial year from previous year's balance, total of which is Rs.16,01,022/-. Thus, a sum of Rs.15,30,453/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

It is pertinent mention here that officer wife (Teacher) having annual income Rs.6,97,285/- & Rs.7,10,196/- respectively for the financial year 2019-20 & 2020-21.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2017-19 (2017-18 & 2018-19) online against case id- P00010912021(old case id-3186) and same has been processed before Hon'ble Mr. Justice Om Prakash Tripathi, Administrative Judge, Sant Kabir Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 19.11.2021. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Mahendra Kumar Singh, Chief Judicial Magistrate, Sant Kabir Nagar at Khalilabad be laid before Hon'ble Mr. Justice Om Prakash Tripathi, Administrative Judge, Sant Kabir Nagar for His Lordship's kind perusal and orders?
