

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Anubhav Katiyar, Additional Chief Judicial Magistrate(Railway), Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Total income is Rs.11,30,555/- (Gross income from salary is Rs.9,80,539/- and Rs.1,50,016/- received from ONGC under Post Retirement Benefit Scheme because the officer worked there as Assistant Legal Advisor prior to joining Judicial Service) and total deductions/savings/ investment against GIS, Income Tax, PPF, LIC Policy, NPS, Car down payment, loan repayment and the balance of his savings bank account(s) is enhanced by Rs.2,82,123/- in this financial year from previous year's balance, total of which is Rs.9,42,850/-. Thus, a sum of Rs.1,87,705/- was therefore available with him to meet out his household expenditure for both the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements at the time of joining online against Case Id-P00005712021 same has been laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, the then Administrative Judge, Bareilly for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) firstly vide online dated 08.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated "that the undersigned is a Judicial Officer of 2015 batch, joining 19.1.2017, presently posted as A.C.J.M. (Railway), Bareilly, the undersigned was required to submit his property details for the financial year 2016-17 and 2017-18 till march, 2019 to the Hon'ble Court. However, the first year of joining went into the training at JTRI, Lucknow and as all property details were kept at Kannauj at the permanent address of the undersigned, therefore it took sometime to collect the details. Besides being a newly appointee, the undersigned was engrossed and focused on the training and performance of his work which resulted in causing delay of the submission of the details. The details of the property are being submitted herewith a humble request to condone the delay caused. The undersigned would be very careful in future to submit the details within time. The undersigned shall be highly obliged"(mentioning in enclosed letter).
