May kindly see the property statement submitted through online service by Sri Abhishek Pandey, Additional District Judge, Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2010-2012 in the prescribed proforma, to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2010-2012 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2010-2012, total income is Rs. 19,82,718/- from salary in these years and, total deductions/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS, Insurance policies, PLI, PPF comes to Rs. 11,72,790/-, which includes inhanced balance in his savings bank account(s) of Rs. 4,31,751/-. Thus, a sum of Rs. 8,09,928/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is also to mention here that his wife Smt. Kalpana Pandey, MA English, LL.B., Diploma in Fashion Designing, has also income of Rs. 3,72,000/- from her profession in these financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2009-2010 before this, which has been seen on 13.05.2013 by Hon'ble Mr. Justice Sanjay Misra, Administrative Judge, Mathura in misc. file of the officer in offline mode earlier.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2010-2012 in its next financial year i.e., 2012-2013 upto March 2013. He has submitted movable and immovable property statements of the financial years 2010-2012 vide online service dated 07.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer, for which he has submitted that due to judcial work and his being Corona positive, he could not sent his Property statemnt within stipulated time. He deeply regretted for the inconvenience and requested to condone the delay of his part.

May, therefore, if approved, property statements of the financial years 2010-2012 of Sri Abhishek Pandey, Additional District Judge, Pilibhit be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Pilibhit for His Lordship's kind perusal and orders?
