Thus, a sum of Rs.6,84,715/- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial year 2019-2021 (2019-20 & 2020-21).

It is pertinent to mention here that his father is an Ex Employee of Private Company (as mentioned by the officer).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining online against Case Id: P00000142021 (Old Case Id: 1952) and the same has been seen by Hon'ble Mr. Justice Ajit Kumar, the then Administrative Judge, Ballia Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 07.03.2022. As such, there is no delay in submitting the same.
