May kindly see the property statement online received from Sri Mukeem Ahmad, Civil Judge (Senior Div.), Moradabad regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his gross income from salary is Rs.32,55,397/- and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, PPF, Repayment of car loan are Rs.13,18,346/-. The balance of Rs.63,321/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.19,37,051/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2019-21 (2019-20 & 2020-21).

It is to pertinent mention here that officer's wife (Judicial officer in Uttar Pradesh) having annual income Rs.9,11,000/- for the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2017-19 (2017-18 & 2018-19) online against case id- P00011352021 (old case id-3232) and same has been processed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 23.11.2021. As such, there is no day delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Mukeem Ahmad, Civil Judge (Senior Div.), Moradabad be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
