May kindly see the online property statements received from Sri Anil Kumar Seth, Special Secretary & Additional L.R. (Legislative), Govt. of U.P., Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.46,99,336/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Home Loan, Car purchase down payment, Car loan, LIC policies, PPF a/c, SIP and the balance of his savings bank account(s) has also been enhanced for Rs.37,016/- this financial year from previous year's balance, total of which is Rs.32,51,551/-. Thus, a sum of Rs.14,47,785/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Bareilly, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 07.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that "I was to send the property statement of the financial Year 2018-2019 and 2019-2020 after march 2020 but due to covid pandemic and lockdown in few months from April 2020, I could not collect the essential details. Hence, I could not send the property statement of the financial Year 2018-19 and 2019-20 in time. If caused any delay, I regret. In future I will be careful in sending the property Statements in time.", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Anil Kumar Seth, Special Secretary & Additional L.R. (Legislative), Govt. of U.P., Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
