May kindly see the property statement online received from Smt. Anuja Singh, Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 and 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2018-20 (from 27.09.2018 to 31.03.2019 and 2019-20), her gross income from salary is Rs.14,16,314/- and total deductions/Savings/investments NPS, GIS, Income Tax and PPF are Rs.4,91,211/-. The balance of Rs.39,500/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.9,25,103/- was therefore available with her to meet out the household expenditure of her family consisting two members in the financial years 2018-20 (2018-19 and 2019-20).

It is to pertinent mention here that officer's husband (Lawyer) having annual income was Rs.5,00,000/- for the financial years 2018-19 and 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement held at the time of Joining in to U.P. Judicial Service online against case id-P00011472021 (old case id:3245), which had already been seen by Hon'ble Mr. Justice Rajesh Singh Chauhan, the then Administrative Judge, Banda Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 and 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She had submitted movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) vide online dated 10.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer's verbatim (in attachment): "Due to lack of knowledge and unprecedented COVID 19 pandemic situation i could not file my property statement within allotted time. I most sincerely apologise for the delay caused on my part. I humbly pray to the Hon'ble Court to kindly accept my sincere apologies. I shall definitely be utmost careful in future. It is requested that my submission may kindly be placed before the Hon'ble Court for kind and sympathetic consideration."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 and 2019-20) of Smt. Anuja Singh, Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
