May kindly see the property statement online received from Sri Bharat Singh Yadav, Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income from salary are Rs.37,01,161/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, GVR, PPF a/c, RD, LIC, Home loan and the balance of his savings bank account(s) has also been enhanced for Rs.7,36,726/- this financial year from previous year's balance, total of which is Rs.25,96,663/-. Thus, a sum of Rs.11,04,498/- was therefore available with him to meet out the household expenditure of his family consisting seven members in both the financial years.

It is pertinent to mention here that his father's monthly pension is Rs.11,601/- & Rs.12,768/- for the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2017-18, which has already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Kasganj with the direction that the officer be asked to submit property statement in time in future, placed in the misc file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 firstly vide online dated 24.11.2021. As such, there is delay in submitting the same from the part of the officer for which officer has stated that *"he was transferred from Kasganj to Allahabad Judgeship during the year 2021. In that period there was delay in the collection of data regarding the property statement, deduction etc. Kindly accept his submissions and forgive for the delay"*, mentioned in his reply dated 20.12.2022.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Bharat Singh Yadav, Additional District & Sessions Judge, Ghaziabad be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
