May kindly see the online letter dated 30.11.2021, received from Sri Shamsul Rahman, Additional Civil Judge (Junior Division), Hapur regarding submission of statement of Movable property exceeding to vale of one month's basic pay and immovable properties acquired/held by him or any member of his family at the time of entering i.e. of joining into U.P. Judicial Service in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that Sri Shamsul Rahman has joined U.P. Judicial Service on 16.12.2019 and as per statement of movable and immovable preperty submitted at the time of entering into U.P. Judicial Service of the officer concerned, following movable and immovable property held by him, are as follows:

- 1. He has households such as A.C., Sofa, T.V. etc (Rs 1,09,500/- approx.) acquired from the salary of the previous job as an Assistant Professor.
- 2. He has 500 gram of Gold, 750 gram of Silver and 50 gram of Diamonds given as a gift to his wife at the time of his marriage on 06/11/2019 and wedding reception on 09/11/2019.
- 3. He has savings bank account no. 30405538912, (SBI, Chandwara Branch

District- Muzaffarpur, Bihar) having balance of Rs. 50,000/-.

- 4. He has SBI Long Term Equity Fund-Regular Plan-Growth, purchased on 28.03.2019. The amount invested is Rs. 5000 per month (total amount invested so far is Rs. 70000/-)
- 5. The Gross income of his previous job as Assistant Professor was Rs. 77888/- per month. The deductions were not uniform and it was between Rs. 6000 to 7000/- per month.
- 6. He has also owned a plot of 0.0395 Acres (1723 Sq. Ft.), purchased by his Father in the year 1994, in his name, when he was a minor. His father built a semi market over the land after constructing small shops which have been given on rent. The annual revenue assessed from this property is Rs. 3,60,000 per year.

It is further submitted that as per policy/ Hon'ble Court's Circular letter, the officer has to submit his property statement at the time of entering into judicial service just after joining into judicial service. He has submitted movable and immovable property statement at the time of joining into U.P. Judicial Service through his online letter dated 30.11.2021 As such, there is delay in submitting the aforesaid property statements from the part of the officer for which he has sincere apologised for the delay caused in his online letter dated 30.11.2021.

May, therefore, if approved, property statement at the time of entering i.e. of joining into U.P. Judicial Service alongwith online letter dated 30.11.2021 of Sri Shamsul Rahman, Additional Civil Judge (Junior Division), Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur Judgeship for Her Lordship's kind perusal and orders?
