May kindly see the property statement online received from Sri Harish Kumar-II, Chief Judicial Magistrate, Lalitpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2015-16 & 2016-17, Total income is Rs.25,99,046/- (Gross salary are Rs.18,09,674/-, received Rs.2,61,942/- & Rs.5,27,430/- as nominee amount after death of his father from LIC & PPF account respectively) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.6,19,023/- this financial year from previous year's balance, total of which is Rs.14,77,306/-. Thus, a sum of Rs.11,21,740/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife's income from Home Tuition was Rs.1,85,000/- per annum.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen offline by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Sitapur, placed in the misc. file of the officer. And for the financial years 2011-12 & 2012-13 and 2013-14 & 2014-15 which had been processed on e-service IDs 2734 and 3032 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 firstly vide online dated 01.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "his father expired on 20.11.2014 and earlier statements were submitted late therefore subsequent statements also got late. He apologise for late submission. Kind request to condone the delay", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2015-16 & 2016-17 of Sri Harish Kumar-II, Chief Judicial Magistrate, Lalitpur be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
