May kindly see the online reply received from Sri Rohit Puri, Addl. Civil Judge (Junior Div.), the then Civil Judge (Junior Division), Saharanpur, presently posted as Addl. Civil Judge (Junior Div.), Chakia-Chandauli, in compliance of order of Hon'ble Mr. Justice Rajeev Gupta, the then Administrative Judge, Saharanpur Judgeship in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the then Administrative Judge, Saharanpur through detailed office note, on which His Lordship has been pleased to pass the following order:

"The officer be asked to submit explanation within fortnight regarding delayed submission of property statement."

The order of the Court had been communicated to the officer. In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated, in his verbatim as under:

"I joined the services on 16-12-2019 and I was not aware of the time frame about the submission of property statement as fixed by the directions of Hon'ble High Court of Judicature at Allahabad. Due to the above fact I mistakenly submitted it late. I seek apology for the same and I assure your goodself that I will be careful and alert in future. Please Kindly condone the delay."

It is further submitted that as per policy/ Hon'ble Court's Circular letter, the officer has to submit his property statement at the time of entering into judicial service just after joining into judicial service. His joining date is 16/12/2019. He has submitted movable and immovable property statement at the time of joining into U.P. Judicial Service through his online letter dated 27.11.2021. As such, there is delay in submitting the aforesaid property statements from the part of the officer. In this regard, officer has given reason for delay and compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sri Rohit Puri, Addl. Civil Judge (Junior Div.), Chakia-Chandauli, be laid before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Chandauli Judgeship for His Lordship's kind perusal and orders?
