May kindly see the online letter 07.12.2021 received from Sri Nadeem Anwar, Additional Chief Judicial Magistrate, Banda regarding submission of statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his gross income from salary enclucing allowances is Rs.22,74,696/- and total deductions/Savings/investments against NPS, GIS, Income Tax is Rs.4,36,080/- (including enhancement of balance of Rs.65,326/- in his saving bank a/c's against the balance of the previous year). Thus a sum of Rs.18,38,616/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2018-20 (2018-19 & 2019-20).

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2017-2018 which had already been approved by Hon'ble Mr. Justice Vivek Kumar Birla, the then Administrative Judge, Banda on old case Id no-410 and the Officer be warned to be careful in future in submitting property statement within time.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e. 2018-2019 upto March, 2019. He has submitted movable and immovable property statements of the financial years 2016-2018 (2016-2017 & 2017-2018) vide online letter dated 07.12.2021. As such, there is delay in submitting the aforesaid property statements from the part of officer. In this regard, he stated that due to unprecedented outbreak of covid-19, he could not submit the same in time. For which he sincerely apologises.

May, if approved, the movable and immovable property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Nadeem Anwar, Additional Chief Judicial Magistrate, Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda Judgeship for Her Lordship's kind perusal and orders?
