May kindly see the property statement received online from Sri Sachin Verma, Civil Judge (Senior Div.), Bansgaon-Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.19,05,916/- and total deductions/savings/investment against GIS, NPS, PPF, RD, FD, Funds, Car Loan repayments including amount paid other than loan and Income Tax is Rs.15,34,005/- and the balance of his savings bank account(s) is also decreased by Rs.82,924/- in this financial year from previous year's balance. Thus, a sum of Rs.4,54,835/- (Rs.3,71,911/- from salary and Rs.82,924/- from SB Account) was therefore available with himself to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20).

It is pertinent to mention here that his father have annual income of approx. Rs. 5 to 6 lacs from Agriculture.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial Service online against Case Id: P00000472019 (Old Case Id: 78) and the same has been seen by Hon'ble Mr. Justice Vivek Kumar Singh, the then Administrative Judge, Bahraich Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 12.12.2021. As such, there is delay in submitting the same for which the officer has stated in his online reply dated 01.02.2023, that "I joined the service on 11-07-2018 and due to want of proper knowledge the statement could not be submitted within prescribed time, I humbly pray for acceptance of the statement."

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Sachin Verma, Civil Judge (Senior Div.), Bansgaon-Gorakhpur, be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
