May kindly see the property statement online received from Smt. Madhu Dogra, ADJ (POCSO), Bhadohi at Gyanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2019-21 (2019-20 & 2020-21), her gross income is Rs.39,71,876/- (Rs.38,41,789/- from salary and Rs.1,30,087/- from other sources) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, FDR and Insurances are Rs.24,28,733/-. The balance of Rs.1,11,900/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.16,55,043/- (Rs.15,43,143/- from salary and Rs.1,11,900/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting two members in the financial years 2019-21 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2017-19 (2017-18 & 2018-19) online against case id- P00016472021 (old case id-3762) and same has been processed before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She had submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 04.12.2021 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Madhu Dogra, ADJ (POCSO), Bhadohi at Gyanpur be laid before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders?
