May kindly see the property statement submitted online received from Smt. Ranjini Shukla, presently posted as Additional Civil Judge(Sr. Div,)/ACJM, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary is Rs. 8,77,804/- and total deductions/savings/investments against , GIS, PPF and R.D is Rs. 2,99,583/- (including enhancement of Rs. 104583/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs.5,78,221/- was therefore available with her to meet out the household expenditure of her family consisting of two members in both the financial years.

It is pertinent to mention here that her father is SDM Sultanpur, having annual income of Rs.10,08,000 yearly.

In this connection, it is submitted that the officer has already submitted his property statements online of at the time of joining into U.P.Judicial Services which is processed on old case id no.3301 before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) online dated 29.11.21. As such there is delay in submitting the aforesaid property statement on the part of officer for which officer has stated that delay happened due to COVID pandemic and personal tragedy in the family.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Smt. Ranjini Shukla, Additional Civil Judge (Sr.Div)/ACJM, Lucknow, be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
