May kindly see the property statement submitted online received from Sri Anurag Sharma, Additional District & Sessions Judge (F.T.C.), Firozabad, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), his Total income from salary and other sources is Rs. 64,31,709/- (Total Salary Rs. 20,06,103/- and received Rs. 44,25,606/- due to death of her mother as a nominee) and total deductions/savings/investments against NPS, GIS, Income Tax, Insurance policy, FD and the balance of his Saving bank A/c(s) is enhanced for Rs. 13,56,082/- this financial year from previous year's balance, total of which is Rs. 58,15,544/-. Thus a sum of Rs. 6,16,165/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2013-15 (2013-14 & 2014-15) which is also processed online and laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Firozabad Judgeship for kind perusal and order on e-service Id no. 3886.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto 31st March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer and the officer has stated that due to death of his mother and further stated that the property statement could not be send in time because of work load and mistake. He felt sorry for not sending property statement in time and humbly requested that the Hon'ble Court may be pleased to forgive him regarding this mistake.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Anurag Sharma, Additional District & Sessions Judge (F.T.C.), Firozabad, be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
