May kindly see the property statement received online from Sri Ashwini Kumar Tripathi, District & Sessions Judge, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary and other sources is Rs.51,87,218/- and total deductions/savings/investment against GIS, NPS, PPF, SIP, Insurances, Loan repayments and Income Tax is Rs.29,16,436/-. Thus, a sum of Rs.22,70,782/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20) and the balance of his savings bank account(s) is also decreased by Rs.3,77,388/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife have annual income of Rs.3,27,293/- & Rs.1,96,790/- by Coaching and interest on saving etc. in both financial years respectively and his daughter have monthly income of Rs.7,500/- by Internship in financial year 2019-20.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial Service offline and the same has been seen by Hon'ble Mr. Justice Arvind Kumar Tripathi, the then Administrative Judge, Ghazipur Judgeship, in the misc. file of the officer. Further, the Officer has also submitted his property statements for the financial year 2008-09 to 2017-18 offline and the same have been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 02.12.2021. As such, there is delay in submitting the same from the part of officer, for which he stated in his online reply dated 04.02.2023, that "*due to COVID-19 conditions the requisite statement and details of account could not be collected from the bank in time hence delay was inadvertent for which I apologise.*"

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Ashwini Kumar Tripathi, District & Sessions Judge, Lucknow, be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
