May kindly see the property statement online received from Sri Rakesh Kumar Yadav, Additional District & Sessions Judge, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-2017 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-2017 of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2015-2017, total income is Rs. 25,10,790/- (Income from salary and Arrears) and total deduction/ repayment/ savings/ investment/ against N.P.S., G.I.S., Income Tax., L.I.C., SBI Life Policy, Reliance Child Plan, Reliance Enowment Plan, repayment of car loan and the balance of his saving bank account is enhanced for Rs. 1,10,004/- this financial year from balance at the time of joining in U.P. Judicial Service, total of which is Rs. 14,07,711/-. Thus, a sum of Rs. 11,03,079/- was available with him to meet out the household expenditure of his family consisting five members for both the financial years 2015-2017.

It is pertinent to mention here that his father is a pensioner having income of Rs. 2,50,000/- and his wife Smt. Kamlesh Rani is working as Deputy Judge Attorney General in I.T.B.P.F. having income of Rs. 5,76,000/- (approx.).

In this connection, it is further submitted that officer has already submitted his property statement at the time of joining in the U.P. Judicial Service which has been processed on the Statement ID no. 3355.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2015-2017 in its next financial year i.e. 2017-2018 upto March, 2018. He has submitted movable and immovable property statements of the financial years 2015-2017 vide online letter dated 04.12.2021. As such, there is delay in submitting the same, for which he has stated that due to illness of his father, he could not submit his property statement. Also, his family was residing at Bhopal (M.P.) as his wife is posted there and he has to travel frequently. He has deeply regretted and apologised for the delay caused in his online letter dated 04.12.2021.

May, therefore, if approved, property statements for the financial years 2015-2017 of Sri Rakesh Kumar Yadav, Additional District & Sessions Judge, Sultanpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
