

## **Joint Registrar (Judicial) (Budget)**

May kindly see the property statement online received from Sri Rakesh Kumar Yadav, Additional District & Sessions Judge, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-2019 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-2019 of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2017-2019, total income is Rs. 39,06,901/- and total deduction/ repayment/ savings/ investment/ against N.P.S., G.I.S., Income Tax., L.I.C., SBI Life Policy, Reliance Child Plan, Reliance Enownment Plan, repayment of car loan and the balance of his saving bank account is enhanced for Rs. 2,08,579/- this financial year from previous year balance, total of which is Rs. 20,66,275/-. Thus, a sum of Rs. 18,40,626/- was available with him to meet out the household expenditure of his family consisting five members for both the financial years 2017-2019.

It is pertinent to mention here that his father is a pensioner having income of Rs. 60,000/- till his demise in July, 2017 and thereafter his mother is family pensioner having income of Rs 2,00,000/- (approx.). His wife Smt. Kamlesh Rani is working as Deputy Judge Attorney General in I.T.B.P.F. having income of Rs. 7,50,000/- (approx.). And, Sri Rakesh Kumar Yadav, Additional District & Sessions Judge, Sultanpur also have 06 STDR amounting to Rs. 7,21,378/- (Total) which was inherited by him after demise of his father on 12.07.2017.

In this connection, it is further submitted that officer has already submitted his property statement at the time of joining into judicial service and for the financial year 2015-2017 which has been processed on the Statement ID nos. 3355 & 3356 respectively.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2017-2019 in its next financial year i.e. 2019-2020 upto March, 2020. He has submitted movable and immovable property statements of the financial years 2017-2019 vide online letter dated 04.12.2021. As such, there is delay in submitting the same, for which officer has not given any reason of delay.

May, therefore, if approved, property statements for the financial years 2017-2019 of Sri Rakesh Kumar Yadav, Additional District & Sessions Judge, Sultanpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Sultanpur for His Lordship's kind perusal and orders?
