May kindly see the property statement received online from Sri Yashwant Kumar Saroj, A.D.J. (FTC), Lalitpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2014-2016 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2014-2016 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2014-2016 (2014-15 & 2015-16), the Gross income is Rs.18,03,262/-(Rs.17,40,262/- from Salary and Rs.63,000/- from maturity of LIC policy) and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Mutual Funds, NSC and Income Tax is Rs.8,78,564/- and the balance of his savings bank account(s) is also increased by Rs.3,80,125/- in this financial year from previous year's balance, total of which is Rs.12,58,689/-. Thus, a sum of Rs.5,44,573/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2014-2016 (2014-15 & 2015-16).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2012-13 & 2013-14 offline and the same has been seen by Hon'ble Mr. Justice V. C. Gupta, the then Administrative Judge, Hamirpur Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-2016 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has firstly submitted movable and immovable property statements of the financial year 2014-2016 (2014-15 & 2015-16) vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated in his online reply dated 13.01.2024, that "due to busy court work and unintentionally by mistake above statement could not filled up within above time."

May, therefore, if approved, property statements for the financial year 2014-2016 (2014-15 & 2015-16) of Sri Yashwant Kumar Saroj, A.D.J. (FTC), Lalitpur, be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
