May kindly see the property statement submitted online received from Sri Siddharth Singh, Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary and other sources (Gross Salary Rs. 42,54,852/-, Maturity amount NSC Rs. 38,000/- Redemption of Reliance Mutual fund 1,58,417/- Maturity of FDR Rs, 1,19,553/-) is Rs. 45,70,822/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, Insurances (LIC, Max New York Life Shikha and Aviva Young Scholar Secure) and Mutual Funds (SIP and ICICI Equity fund investment) is Rs. 18,60,012/-. Thus a sum of Rs. 27,10,810/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. The balance of his savings bank account(s) is also reduced for Rs. 41,824/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Mrs. Archana Singh is working as Librarian in S.P.V.G., Sanatan Dharm Degree College, Unnao .Her annual income is Rs. 4,40,000/- and Rs. 4,85,000/- respectively in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Raebareli on e-service old Case Id no. 847.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 15.12.2021. As such, there is some delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Siddharth Singh, Additional District & Sessions Judge, Aligarh, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders?
