

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Vinod Kumar Yadav, Civil Judge (Senior Div.), Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2018-2020 (2018-19 & 2019-20)**, the Gross income from salary is Rs.17,27,385/- and total deductions/savings/investment against GIS, NPS, PPF and Income Tax is Rs.3,29,358/- and the balance of his savings bank account(s) is also increased by Rs.6,54,998/- in this financial year from previous year's balance, total of which is Rs.9,84,356/-. Thus, a sum of Rs.7,43,029/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20). It is pertinent to mention here that his father has been retired from the government post in Defence Account Department in April 2017.

In this connection, it is submitted that the Officer has already submitted his property statements held at the time of joining into U.P. Judicial Service online against Case Id : P00013112021 (Old Case Id : 3418) and the same have been seen by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Basti Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 06.12.2021. As such, there is delay in submitting the same from the part of officer, for which he has stated in his online reply dated 24.07.2024, that "*due to human error , I submitted aforesaid property statement by delay. For that delay I highly apologize and in future I will always submit property statements in prescribed period.*"

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Vinod Kumar Yadav, Civil Judge (Senior Div.), Basti, be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
