May kindly see the property statement received online from Dr. Avanish Kumar-II, Spl. Judge (U.P. Dacoity.A.A.), Jalaun at Orai regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.41,77,526/- and total deductions/savings/investment against GIS, NPS, SIP, Insurances and Income Tax is Rs.13,59,479/- and the balance of his savings bank account(s) is also increased by Rs.1,85,674/- in this financial year from previous year's balance, total of which is Rs.15,45,153/-. Thus, a sum of Rs.26,37,373/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id : P00012602021 (Old Case Id : 3365) and the same has been processed before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 04.12.2021. As such, there is delay in submitting the same from the part of the officer for which the officer has stated in his online reply dated 31.07.2024, that:

"It is humbly submitted that earlier I sent it physically due to ignorance, but it was suggested to me that combined two years statement needs to be filed together on portal. Then due to some personal engagement and busy court schedule, I could not submit it in time, for which I seek apology for the delay.

Therefore it is humbly requested to condone the delay and proceed further."

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Dr. Avanish Kumar-II, Spl. Judge (U.P. Dacoity.A.A.), Jalaun at Orai, be laid before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
