May kindly see the online property statements received from Mohd. Ahmad Khan, Additional District & Sessions Judge (POCSO), Fatehpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, Total Gross income (both the financial years) is Rs.39,92,310/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, HRR and the balance of his savings bank account(s) is enhanced for Rs.8,74,432/- in this financial year from previous year's balance, total of which is Rs.19,45,217/-. Thus, a sum of Rs.20,47,093/- was therefore available with him to meet out the household expenditure of his family consisting six members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Pratyush Kumar, the then Administrative Judge, Banda, placed in the misc. file of the officer and of the financial years 2016-17 & 2017-18 has been processed & a separate note has been made on e-service ID no.P00013382021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"Due to heavy work load, Corona pandemic obtaining time to time E.L./ M.L. he could not submit salary statements within stipulated period for which he has seek unconditional apology and he would like to ensure that in future he will submit desired property statements with in time"*, mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Mohd. Ahmad Khan, Additional District & Sessions Judge (POCSO), Fatehpur be laid before Hon'ble Mr. Justice Narendra Kumar Johari, Administrative Judge, Fatehpur for His Lordship's kind perusal and orders?
