In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary is Rs.22,40,216/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, LIC and repayment of car loan, total of which is Rs.7,85,923/-. Thus, a sum of Rs.14,54,293/- was available with his to meet out the household expenditure of himself in both of the financial years. And the balance of his savings bank account(s) is reduced by Rs.2,50,615/- this financial year from previous year's balance.
