May kindly see the property statement online received from Sri Mritunjay Srivastava, Secretary, District Legal Services Authority, Shravasti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2019-21, total income is Rs.34,65,376/- (Gross salary is Rs.29,24,274/-, encashment of F.D. Of Rs.4,11,102/- and rent from flat of Rs.1,30,000/-) and total deduction/ repayment/ savings/ investment/ against L.I.C., G.I.S., P.P.F., NPS, Income Tax, loans, F.D. and paid against purchase of flat are Rs.20,44,973/-. Thus, a sum of Rs.14,20,403/- was available with him to meet out the household expenditure of his family consisting four members for both the financial years. And the balance of his savings bank account is also reduced for Rs.46,153/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is Scale-II Manager in Punjab National Bank having annual income of Rs.11,00,000/-(approx).

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2015-2017 which had already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Bareilly on the miscellaneous file of the officer with the remark "In future promptness must be shown in declaration" and statement of 2017-19 be processed online on case ID-849.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e. 2021-22 upto March, 2022. He has submitted movable and immovable property statements of the financial years 2019-21 vide online letter dated 09.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Mritunjay Srivastava, Secretary, District Legal Services Authority, Shravasti be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Shravasti for His Lordship's kind perusal and orders?
