

## **Joint Registrar (Judicial) (Budget)**

May kindly see the property statement submitted online received from Sri Abhinav Tiwari, Secretary, District Legal Services Authority, Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary and other sources (Salary Rs. 17,86,469/-, bank interest Rs. 22573/- and maturity of F.D. 5,25,634/-) is Rs. 23,34,676/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, FD, LIC, SIP (HDFC MF), RD and the balance of his Saving bank A/c(s) is enhanced for Rs. 19,461/- this financial year from previous year's balance, total of which is Rs. 11,45,347/-. Thus a sum of Rs. 11,89,329/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that his father's and mother's income are Rs. 8 lac and 6 lac respectively and his wife is also self employed. Her annual income is Rs. 3 lac approx.

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Rakesh Srivastava, the then Administrative Judge, Faizabad on e-service old Case Id no. 322.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 06.12.2021. As such, there is delay in submitting the same from the part of the officer, for which he has stated that "*important details could not be collected within time due to Corona Pandemic. Officer has apologized for the delay caused in submission of property statement and also assures that the further statements will be submitted within time in future.*"

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Abhinav Tiwari, Secretary, District Legal Services Authority, Pilibhit, be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Pilibhit for His Lordship's kind perusal and orders?
