May kindly see the property statement online received from Sri Anurag Yadav, Additional Civil Judge (Sr.Div.)/ACJM, Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.17,24,033/- and total deductions/repayment/savings/investment against NPS, GIS, Income Tax and the balance of his savings bank account(s) is also enhanced by Rs.1,16,812/- this financial year from previous year's balance, total of which is Rs.3,45,038/-. Thus, a sum of Rs.13,78,995/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both of the financial years. It is pertinent to mention here that his wife is also working as Civil Judge, having annual income of Rs.660397/-, as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted his property statements of the joining online against Case Id : P00009842021 and the same has also been processed online before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Jhansi for His Lordship's kind perusal and orders

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he has stated (in his verbatim) that "due to loss of some NSC and KVP papers at applicant's home district the property statement of the above financial year could not be submitted in time for which the applicant seeks apology".

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Anurag Yadav, Additional Civil Judge (Sr.Div.)/ACJM, Jhansi be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Jhansi for His Lordship's kind perusal and orders?
