

**Joint Registrar (Judicial) (Budget)**

May kindly see the property statement submitted online received from Sri Aishwarya Pratap Singh, A.C.J.M. (Railway) Aligarh. regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary and other sources (Salary Rs. 25,92,522/- and maturity of F.D.R. 5,33,252/-) is Rs. 31,25,774/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, FDR and the balance of his Saving bank A/c(s) is enhanced for Rs. 11,22,129/- this financial year from previous year's balance, total of which is Rs. 21,97,776/-. Thus a sum of Rs. 9,27,998/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Kanpur Nagar in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 05.12.2021. As such, there is delay in submitting the same from the part of the officer and he has submitted that the delay caused in submitting the above statement may kindly be condoned, as the delay of a few months was due to the outbreak of the global pandemic COVID 19, and the closure of the Courts during that period. The applicant shall be forever grateful for the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Aishwarya Pratap Singh, A.C.J.M. (Railway) Aligarh, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders?
