May kindly see the property statement online received from Sri Ranvijay Singh, Additional Chief Judicial Magistrate (Railway), Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), his gross income from salary is Rs.20,38,529/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, NSC, Insurances and Mutual fund are Rs.6,92,637/-. The balance of Rs.21,603/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.13,45,892/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2017-19 (2017-18 & 2018-19).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-17 (2015-16 & 2016-17) online against case id-P00007712023 and same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 11.10.2023. As such, there is delay in submitting the same. In this regard, officer verbatim: "Undersigned couldn't submit property statement on time due to family engagements and attachment in JTRI Lucknow from 27 August 2019 to Jan 2020. Corona Pandemic and consequent lock-down has also diverted attentions."

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Ranvijay Singh, Additional Chief Judicial Magistrate (Railway), Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
