May kindly see the online letter 30.11.2019 received from Smt. Meena Srivastava, the then Judicial Member, Commercial Tax Tribunal, Gorakhpur presently posted as Judge, Special Court, CBI, Lucknow regarding submission of statements of movable and immovable properties for the financial year 2014-15 proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-15 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

**1.** In the financial year 2014-15, her gross income from salary and other sources is Rs. 14,10,838/- (Rs. 13,35,079/-from salary, Rs. 75,759/- from bank interest and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, and LICs is Rs. 6,75,053/-. Thus a sum of Rs. 7,35,785/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2014-15. The balance of Rs. 1,544/- from her saving bank has decreased against the balance of the previous year.

It is pertinent to mention that the husband of the officer, Sri Praful Kamal is a JSCC in Kanpur Nagar whose annual income is Rs. 14,77,646/- in the financial year 2014-15.

In this connection it is submitted that Smt. Meena Srivastava has already submitted her property statements up to the financial year 2013-14 which has already been seen by Hon'ble Mr. Justice Tarun Agarwala, the then Administrative Judge, Kanpur Nagar in the personal file of the Officer.

The movable and immovable property statement for the financial year 2014-15 have been submitted by the Officer vide her **online case id no. 354 dated 20.11.2019** which is due to be submitted up to the end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer for which no explanation has been submitted by the officer concerned.

Hon'ble The Administrative Committee vide minutes dated 11.02.2011 has resolved that- "The property statements be submitted before The Hon'ble Administrative Judge of the district where the officer is posted".

May, if approved, the movable and immovable property statements for the financial year 2014-15 of Smt. Meena Srivastava, Judge, Special Court, CBI, Lucknow be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
