May kindly see the property statement submitted online received from Sri Om Pal Singh, Chief Judicial Magistrate, Amroha regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

**In the financial year 2019-21 (2019-20 & 2020-21)**, his Total income is Rs.31,04,933/- and total deductions/savings/investments against NPS, GIS, Income Tax, LIC Policies are Rs.9,37,272/-. Thus a sum of Rs.21,67,661/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his S.B. A/Cs is reduced by Rs.14,22,606/- this financial year from previous year's balance.

It is pertinent to mention here that Officer's Wife- Smt. Rashmi Singh is PGT in English in Kendriya Vidyalaya Babugarh, District-Hapur, her salary is about Rs.1,10,000/- per month.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2017-19 (2017-18 and 2018-19) which has already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Gautam Buddha Nagar Judgeship on old case Id no-601.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 08.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Om Pal Singh, Chief Judicial Magistrate, Amroha be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders?
