May kindly see the property statement online received from Sri. Saket Bihari Deepak, Presiding Officer, Commercial Court Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1)In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.56,48,241/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, GVR, PPF, LIC policy's, Shares and the balance of his savings bank account(s) is enhanced by Rs.13,43,441/- this financial year from previous year's balance, total of which is Rs.28,67,922/-. Thus, a sum of Rs.27,80,319/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 offline and same has been moved before the Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur Judgeship in misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 04.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that "it is respectfully submitted that after sudden demise of respected father all immovable properties as agricultural lands and buildings devolved upon me and my sister. But the family settlement and mutation proceedings have not taken place during this period. Therefore, information as to actual inherited ancestral properties will be given to the Hon'ble Court susequently after the completion of family settlement and mutation proceeding. In this context, it is most repectfully submitted that except few, almost all bank accounts and fixed deposits are in various branches of different banks located in state of Bihar and due to the Covid pandemic I was not able to obtain the status of these bank accounts, therefore the property statement could not be submitted to The Hon'ble Court within stipulated period and for which kindly excuse me and delay may be condoled."
