In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial year 2016-17, her gross income from salary and other sources is Rs. 16,87,163/- (Rs. 16,20,834/- from salary, Rs. 66,329/- from bank interest) and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, and LICs is Rs. 8,49,205/- (including enhancement of balance of Rs. 56,326/- in her saving bank A/c against the balance of the previous year). Thus a sum of Rs. 8,37,958/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2016-17.

It is pertinent to mention that the husband of the officer, Sri Praful Kamal is an Addl. District and Sessions Judge, UP Judicial Services whose annual income is Rs. 15,09,728/- in the financial year 2016-17.

In this connection it is submitted that Smt. Srivastava has already submitted her property statements upto the financial year 2013-14 which has already been seen by Hon'ble Mr. Justice Tarun Agarwala, the then Administrative Judge, Kanpur Nagar in the personal file of the Officer. For the preceding financial year, she has submitted her property statements for the financial years 2014-15 and 2015-16 which have been processed presently online and separate office notes have already been submitted for orders on separatecase id nos. 354 and 355.

The movable and immovable property statement for the financial year 2016-17 has been submitted by the Officer vide her online case id no. 357 dated 21.11.2019 which is due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer.
