May kindly see the property statement submitted online, received from Smt. Meena Srivastava, Judge, Special Court, CBI, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2017-18, Total income is Rs.19,07,375/- (income from salary is Rs.17,66,074/-, Bank interests of Rs.36,721/-, T.A. of Rs.53,800/-, LIC money back policy of Rs.20,000/- and redemption of bond of Rs.30,780/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, LIC, Car down payment, Plot purchase payment and Car loan are Rs.24,24,719/-. And the balance of her savings bank account(s) is also reduced for Rs.7,81,077/- this financial year from previous year's balance. Thus, a sum of Rs.2,63,733/- was therefore available with her to meet out the household expenditure of her family consisting four members in whole of the financial year.

It is pertinent to mention here that her husband is A.D.J. having annual income of Rs. 16,51,704/-.

In this connection it is submitted that the officer has already submitted her property statements upto the financial year 2013-14 which has already been seen by Hon'ble Mr. Justice Tarun Agarwala, the then Administrative Judge, Kanpur Nagar in the Misc. file of the Officer. For the preceding financial year, she has submitted her property statements for the financial years 2014-15, 2015-16 and 2016-17 which have been processed presently online and separate office notes have already been submitted for orders on separate case id nos. 354, 355 and 357.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statement for the financial year 2017-18 firstly vide online dated 18.12.2019. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2017-18 of Smt. Meena Srivastava, Judge, Special Court, CBI, Lucknow be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
