May kindly see the property statement submitted online received from Smt. Archana Yadav, Additional District Judge (FTC), Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2019-21 (2019-20 & 2020-21), Total income from salary is Rs.39,22,412/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS, PPF, Repayment of loans and SIP are Rs.21,43,993/-. Thus, a sum of Rs.17,78,419/- was therefore available with him to meet out the household expenditure of her family consisting three members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.39,924/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is Judicial Officer of the U.P. Nyayik sewa and salary is same as her.

In this connection, it is submitted that the officer has already submitted her property statements of the financial year 2017-19(2017-18 & 2018-19) online against case id-P00007412020 (old case id-1570) ,which had already been seen by Hon'ble Mr. Justice Deepak Verma, the then, Administrative Judge, Rampur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 06.12.2021. As such, there no delay in submission of property statement.

May, therefore, if approved, property statements of the financial years 2019-21 (2019-20 & 2020-21) of Smt. Archana Yadav, Additional District Judge (FTC), Lucknow be laid before Hon'ble Mrs. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
