In the financial years 2009-11 (2009-10 & 2010-11), Total income from salary is Rs.7,64,924/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, LIC, NSC, Bond, repayment of car loan and the balance of his savings bank account(s) is enhanced by Rs.64,390/- this financial year from previous year's balance, total of which is Rs.2,94,838/-. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that due to ill-health of his mother and other family members, he could not send the aforesaid property statement earlier. He sincerely submits his apologies for the same.
