May kindly see the property statement submitted online received from Sri Satya Pal Singh Premi, Judge Small Causes Court, Prayagraj, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:

**In the financial year 2019-21 (2019-20 & 2020-21)**, total income from salary is Rs.33,19,970/- and total deductions/savings/investments against CPF, GIS, Income Tax, PPF, LIC, Ded. U/S 80C & U/S 80CCD and the balance of his savings bank account(s) is also enhanced for Rs.66,287/- this financial year from previous year's balance, total of which is Rs.13,43,232/-. Thus a sum of Rs.19,76,738/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his wife Mrs. Madhu Singh, Practising as Lawyer at High Court, Annual Income approx. Rs.5 lacs.

In this connection, it is submitted that the officer has already submitted his property statements for financial years 2017-19 which is already seen offline by Hon'ble Mr. Justice Ram Surat Ram (Maurya), the then Administrative Judge, Allahabad Judgeship in the Misc. file of the officer .

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e. 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide his application dated 08.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21( 2019-20 & 2020-21) of Sri Satya Pal Singh Premi, Judge Small Causes Court, Prayagraj, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad Judgeship for Her Lordship's kind perusal and orders?
