May kindly see the property statement submitted online received from Smt. Jyotsna Singh, presently posted as Civil Judge (Junior Div.), Aligarh. regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), her Total income from salary and other sources (Salary Rs. 18,15,699/- and received from maturity of F.D.R. Rs. 3,97,282/-) is Rs. 22,12,981/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, and the balance of his Saving bank A/c(s) is enhanced for Rs. 13,64,801/- this financial year from previous year's balance, total of which is Rs. 17,67,292/-. Thus a sum of Rs. 4,45,689/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years.

It is pertinent to mention here that the Officer's husband Mr. Aishwarya Pratap Singh is A.C.J.M. (Railway), Aligarh and his gross monthly income is Rs. 1,13,893/- in this financial year.

In this connection, it is submitted that the officer has already submitted her property statements online at the time of joining into U.P. Judicial Service which had already been seen by Hon'ble Mrs. Justice Sunita Agarwal, the then Administrative Judge, Kanpur Nagar on e-service case Id no. 125.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide her application dated 06.12.2021. As such, there is delay in submitting the same from the part of the officer and she has humbly prayed that the delay caused in submitting the above statement may kindly be condoned as the delay of a few months was due to the outbreak of global pandemic COVID-19 and the closure of the courts during that period. She will be forever grateful for the same.
