May kindly see the property statement online received from Sri Rajneesh Mohan Verma, Deputy Director, Institute of Judicial Training & Research, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.35,68,882/- (Gross income is Rs.32,90,355/-, and income from bank interests in FDR accounts of Rs.2,78,527/-) and total deductions/repayment/ savings/ investment against PLI, GIS, PPF, Tuition Fees, NPS, Income Tax, Sukanya Samridhhi Yojna, Mutual funds and the balance of his savings bank account(s) is enhanced for Rs.99,619/- this financial year from previous year's balance, total of which is Rs.12,36,685/-. Thus, a sum of Rs.23,32,197/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that the officer has mentioned compensation paid by National Highway Authority of India (for acquiring his land in Mau) to the officer is Rs.50,74,675/- in the statements of 2016-17 and from that amount, officer has purchased One Residential Land situated in Shushant Golf City Lucknow, District Lucknow from M/s. Ansal Properties and Infrastructure Ltd. in the Month of February 2019 for a Consideration of Rs.42,00,000/-.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2015-16 which has already been seen by Hon'ble Mukhtar Ahmad, the then Administrative Judge, Kushinagar and statements of 2016-17 & 2017-18 be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Lucknow for kind perusal & order, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "the above statement was due to be submitted in the financial year 2020-21 but he could not submit the same in due time as he was transferred from Shamli to Lucknow in the month of December, 2019, he could get his all households shipped only in the month of March 2020 but the lockdown started in the March itself. He could not unpacked his households and could not get the statements of accounts and return. During Covid pandemic, he and all of his family members including his kids were severely infected by Covid-19 virus on two occasions (in 2020 and in 2021), which prevented him to attend the office for long period. Owing to his medical condition and unavailability of detailed figures of accounts and returns, the statement could not be submitted in the financial year 2020-21 by him. He seeks unconditional apology for delay from the core of his heart and whatsoever delay is there, it is due to inevitable circumstances and requested to condone the delay." mentioned in attachment "Covering letter".

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Rajneesh Mohan Verma, Deputy Director, Institute of Judicial Training & Research, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
