May kindly see the property statement submitted online dated 10.12.2021 received from Sri Rajesh Kumar Mishra, Additional District & Sessions Judge, Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties of the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2019-21 (2019-20 & 2020-21), Gross income is Rs.42,87,555/-(income from salary is Rs.41,28,714/- & income from Allowances Rs.1,58,841/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, LIC policies, Income Tax with cess, Repayment of Home loan & Personal Loan and the balance of his savings bank account(s) is also increased for Rs.7,05,668/- this financial year from previous year's balance, total of which is Rs.23,40,778/-. Thus, a sum of Rs.19,46,777/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

In this connection, it is submitted that he has submitted his property statement upto the financial year 2018-19 which has already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Lakhimpur Kheri on old case Id no-508.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 10.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2019-21 (2019-20 & 2020-21) of Sri Rajesh Kumar Mishra, Additional District & Sessions Judge, Gautambuddha Nagar be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautambuddha Nagar Judgeship for His Lordship's kind perusal and orders?
