In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2016-18 (2016-17 & 2017-18), her total income from salary encluding allowances is Rs.8,80,942/- and total deductions/savings/investments against CPF, GIS, Income Tax, PPF, repayment of car loan and the balance of his Saving bank A/c(s) is enhanced for Rs.51,306/- this financial year from previous year's balance, total of which is Rs.3,41,895/-. Thus a sum of Rs.5,39,047/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband Mr. Anirudh Kumar Singh, transport work (school van) income Rs. 3.8 lac annually.

In this connection, it is submitted that the officer has already submitted her property statements at the time of joining which had already been processed before Hon'ble Mr. Justice Brij Raj Singh, Administrative Judge, Kasganj on old case ID no.3397.
