May kindly see the property statement submitted online dated 09.12.2020 received from Smt. Tripta Chaudhary, Spl. J. (SC/ST, Pev.of Atroci Act), Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2012-13 & 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-13 & 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2012-13 & 2013-14, total income is Rs.20,28,334/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, LIC policy, SBI Life policy and PPF a/c are Rs.7,59,962/-. Thus, a sum of Rs.12,68,372/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.1,625/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is A.C.J.M-1 having annual Income of Rs.11,02,059/- approx. in the year 2013 and Rs.12,00,000/- approx. in 2014 as secretary ,DLSA,Mathura

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Sabhajeet Yadav, the then Administrative Judge, Banda in the misc. file of the officer. And of the financial years 2010-11 & 2011-12 are already processed & a separate note has (made on case-id no.339) submitted before Hon'ble Administrative Judge, for kind perusal & orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2012-13 & 2013-14 in its next financial year i.e., 2014-15 upto March 2015. She has submitted movable and immovable property statements of the financial years 2012-13 & 2013-14 firstly vide online dated 18.12.2019. As such, there is delay in submitting the same from the part of the officer for which she has stated that delay is by slip of mind, apologies in her reply dated 05.12.2020.

May, therefore, if approved, property statements of the financial years 2012-13 & 2013-14 of Smt. Tripta Chaudhary, Spl. J. (SC/ST, Pev.of Atroci Act), Muzaffarnagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
