May kindly see the online letter received from Sri Ashish Jain, Presiding Officer, Motor Accident Claims Tribunal, Sant Kabir Nagar regarding submission of statements of movable and immovable properties for the financial years 2019-21(2019-20 and 2020-21) on proper proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21(2019-20 and 2020-21) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2019-21(2019-20 and 2020-21), his gross income is Rs.52,99,601/-((income from salary including leave encashment is Rs.51,69,002/- and income from S.B. Interests Rs. 1,30,599/-) and total deductions /Savings/investments against NPS, GIS, income tax, RD, Sukanya Samriddhi Yognaz, insurances, Government vehicle rent, PPF and the balance of his S.B.A/c is also increased for Rs.6,06,434/- against the balance of the previous year, total of which is Rs.33,75,039/-. Thus a sum of Rs.19,24,562/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2019-21(2019-20 and 2020-21).

It is pertinent to mention that the wife of the officer, Mrs. Shweta Jain earns from teaching (tuition), annual income is Rs.4,10,000/- in the financial year 2019-20 & Rs. 4,40,500/- for F.Y. 2020-21.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2017-19 which has already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Hathras on old case id no.771.

The movable and immovable property statement for the financial years 2019-21(2019-20 and 2020-21) have been submitted by the Officer vide online dated 21.12.2021 which were due to be submitted upto the end of the financial year 2021-22. As such, there is no delay in submitting the aforesaid property statements from the part of the officer.

May, if approved, the statements of movable and immovable property for the financial years 2019-21(2019-20 and 2020-21) of Sri Ashish Jain, Presiding Officer, Motor Accident Claims Tribunal, Sant Kabir Nagar kindly be laid before Hon'ble Mr. Justice Om Prakash Tripathi, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
