May kindly see the property statements online received from Sri Saurabh Srivastava-I, Chief Judicial Magistrate, Maharajganj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2017-19 (2017-18 & 2018-19), Total income from salary is Rs.23,66,024/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, mutual fund, PPF, RD & FD, total of which is Rs.14,42,290/-. Thus, a sum of Rs.9,23,734/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his savings bank account(s) is reduced for Rs.37,178/- this financial year from previous year's balance.

It is pertinent to mention here that wife of the officer Smt. Astha Srivastava is ACJM, UP Judicial Service, having annual income Rs. 13 lac approx.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2016-17 which had already been seen by Hon'ble Mrs. Justice Sunita Agarwal, the then Administrative Judge, Unnao with the warning issued to "the officer is warned to submit complete property statement of both movable & immovable property on time in future." (which is informed to the officer by the Court's letter no.4418 dated 24.3.2021 in the misc. file of the officer).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 08.12.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Saurabh Srivastava-I, Chief Judicial Magistrate, Maharajganj be laid before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj Judgeship for His Lordship's kind perusal and orders?
