May kindly see the online property statements received from Sri Ashutosh Kumar Singh, Additional District & Sessions Judge (F.T.C.), Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, Total income from salary is Rs.13,49,018/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PPF a/c, PLI, Insurance policies and FDR are Rs.12,53,710/-. Thus, a sum of Rs.95,308/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,06,945/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is a Judicial Officer, earns annual income of Rs.9,30,629/- & Rs.7,61,928/- during the financial years 2014-15 & 2015-16 respectively.

In this connection it is submitted that he has already submitted his property statement upto the financial year 2009-10 (in the misc. file of the officer), which has been seen by Hon'ble Mr. Justice Rajiv Sharma, the then Administrative Judge, Gorakhpur and property statement of the financial years 2010-12 and 2012-14, which has been processed presently online and separate office note has already been submitted for order on separate e-service ID 3745 and 3760 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements for the financial years 2014-16 vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "due to certain unavoidable reasons and due to misplacement of certain bank accounts and insurance policy related documents, the same could not be sent earlier, for which he convey his sincere apologies and undertakes to adhere to timely submission of the same in near future" mentioned in the attachment "apology" attached in the statement of 2010-12.

May, therefore, if approved, property statements for the financial year 2014-15 & 2015-16 of Sri Ashutosh Kumar Singh, Additional District & Sessions Judge (F.T.C.), Sonbhadra be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
